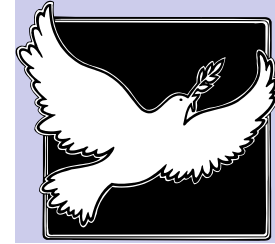

What Is The Endowment Fund?

Living Saviour's Endowment Fund is a fund established by the congregation in which a small percentage of the market value of the fund is used each year to further our mission: ***“Living Saviour welcomes people to Jesus Christ, equips them to grow in faith and send them to serve others”.***

Lasting Stewardship

The purpose of the Endowment Fund is to extend the mission outreach of Living Saviour beyond the normal operating budget. By encouraging, receiving and administering special gifts, the Endowment Fund is designed to assist members in their stewardship of the earthly blessings given to them by Christ, including blessings accumulated over a lifetime.

The primary aims of the Endowment Fund will be financial support for:

- (1) Missions: local, regional and world projects.
- (2) Education: college and seminary assistance.
- (3) Youth: support for youth of all ages.



How Does the Endowment Fund Differ From Sunday Collections?

Giving through the collection plate on Sundays provides funds to serve the operational needs of Living Saviour and specific ministries (For example: Room at the Inn) which are included in the church's annual budget. The Endowment Fund provides opportunities for us to expand our reach in support of additional ministries to further our mission. It is not an emergency fund for unplanned expenses.



How Is The Endowment Fund Managed?

The Endowment Fund is administered and managed by the Endowment Fund Committee made up of 7 voting members of the congregation approved by the Congregation Council. These members serve a 3 year term. All assets of the Endowment Fund are invested by professional investment managers.

How To Participate

You are invited to help provide additional funds for the future of God's work through Living Saviour's Endowment Fund. Gifts may be for any amount and can occur in a number of ways, including, but not limited to, the following:

- (1) Cash Contributions
- (2) Bequest by Will or Trust
- (3) Life Insurance Policies
- (4) Real Estate and Securities
- (5) Memorial Gifts

All inquiries and gifts will be held in strictest confidence, to the extent of the gift giver's wishes.
