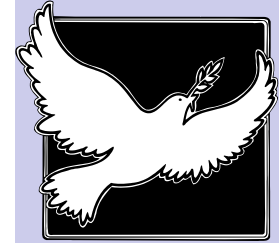

“What Is The Endowment Fund?”

“Living Saviour’s Endowment Fund is a fund established by the congregation in which the principal is retained and the earnings on the fund or a percentage of the market value of the fund is used to further Living Saviour’s mission of [Growing & Serving in Christ” or “Connecting People to Jesus”]. The Endowment Fund can accept current giving through cash or other assets, and future gifts, established by bequests, life insurance or other ways, as people desire to leave a legacy for ministry. The Endowment Fund differs from giving through the collection plate on Sundays and annual pledges which allow us to provide for the operational needs of the Church, and charity and mission work on an annual basis. The Endowment Fund’s emphasis is to support, long-term, the on-going ministries and mission of Living Saviour through gifts from donors intended as a lasting benefit for these ministries.



“Lasting Stewardship”

The purpose of the Endowment Fund is to extend the mission outreach of Living Saviour beyond the normal operating budget. By encouraging, receiving and administering special gifts, the Endowment Fund is designed to assist members in their stewardship of the earthly blessing given to them by Christ, including blessings accumulated over a lifetime.

The primary aims of the Endowment Fund will be financial support for:

- (1) Missions: local, regional and world projects;
- (2) Education: college and seminary assistance;
- (3) Youth: support for youth of all ages; and
- (4) Capital Projects: Major renovations and building of new facilities.



“How Is The Endowment Fund Managed?”

The Endowment Fund is administered and managed by the Endowment Fund Committee made up of 7 voting members of the congregation elected by the Congregation Council. These members serve a 3 year term. All assets of the Endowment Fund are invested by outside investors.

How To Participate”

You are invited to help provide additional funds for the future of God’s work through Living Saviour’s Endowment Fund. Gifts may be for any amount and can occur in a number of ways, including, but not limited to, the following:

- (1) Cash Contributions;
- (2) Bequest by Will or Trust;
- (3) Life Insurance Policies;
- (4) Real Estate and Securities; and,
- (5) Memorial Gifts. All inquiries and gifts will be held in strictest confidence, to the extent of the gift giver’s wishes.
